

Privacy statement

CUSTOMER LOYALTY

CJC B.V. (hereinafter: CJC) attaches great importance to your privacy as a buyer of our products and / or as a visitor to our website. By means of this privacy statement we therefore wish to inform you about how CJC handles your personal data. CJC handles your personal data in accordance with the provisions included in the General Data Protection Regulation (GDPR).

CONTROLLER

CJC B.V. is the company that determines the purpose and means for the processing of the personal data obtained from you and is therefore also the so-called controller.

ACQUISITION

CJC may receive your personal data through your retailer if you order a product manufactured by CJC through your retailer. CJC may also receive your personal data directly from you if there is direct contact with CJC or if you use our website.

PERSONAL DATA

Personal data is data that can be used to directly or indirectly identify an individual. CJC may process the following (types of) of your personal data:

- I. Identification data (name, address data);
- II. Contact details (telephone number, e-mail address);
- III. Clothing sizes.

BASIS

The aforementioned personal data can be processed by CJC on the basis of one of the following legal bases:

- I. The processing is necessary for the performance of an agreement;
- II. The processing is necessary in order to be able to comply with legal obligations that rest on CJC;
- III. CJC has a legitimate interest in processing your personal data.

PURPOSE

Your personal data will only be obtained and processed for the following purposes:

- I. To be able to manufacture and expire the ordered products;
- II. To communicate with you if necessary in connection with the ordered products;
- III. To comply with legal, tax and / or administrative obligations.

CJC attaches great importance to the security of your personal data. CJC has therefore taken appropriate measures to protect your personal data against misuse, loss, unauthorized access, modification, disclosure and other unauthorized use.

SUB-PROCESSORS

Your personal data will only be shared by CJC with third parties to the extent necessary for the manufacture of the products ordered by you. In doing so, CJC ensures that

appropriate measures are taken to respect the confidentiality of your data and to guarantee its integrity. Under no circumstances will CJC provide your personal data to third parties for any form of compensation. If the manufacture of the products ordered by you requires that data be received outside the European Union, CJC will ensure that this data no longer qualifies as personal data, because it is no longer identifiable.

RIGHTS

You have certain rights – detailed below – with regard to the personal data that CJC processes about you. You can exercise your rights at any time by sending your question or request to info@cjc.amsterdam. For the sake of completeness, we inform you that such a question or request can only be processed if it relates to your own personal data.

I. The right to be informed

You have the right to clear and transparent information about how CJC handles your personal data. This privacy statement has therefore been drawn up by CJC.

II. The right of access

You have the right to request CJC to provide you with access to the personal data that CJC has about you.

III. The right to rectification

You have the right to request CJC to change your personal data.

IV. The right to erasure

You have the right to request CJC to delete your personal data.

V. The right to restriction of processing

You have the right to request CJC to process less of your personal data.

VI. The right to data portability

You have the right to request CJC to transfer your personal data to a third party.

VII. The right to object

You have the right to object to the processing of your personal data by CJC.

VIII. The right not to be subject to automated decision-making

You have the right to request CJC not to be subject to automated decision-making. For the sake of completeness, we hereby inform you that there is no automated decision-making by CJC.

If you have a complaint about the handling of your personal data by CJC, you can contact the Dutch Data Protection Authority.

RETENTION PERIOD

CJC stores your personal data for as long as is necessary for the purpose for which it is processed. However, it may happen that CJC has a legal obligation to retain, in which case your personal data may be kept longer than is necessary for the purpose of the processing.

AMENDMENTS

CJC reserves the right to change this privacy statement unilaterally. In case of changes, the new version will replace the previous version and this latest version will automatically take effect. It is therefore advisable to consult this privacy statement regularly.
